

PLAYING RULES & TEAMS

The high school coed program follows USSF soccer rules except for CUSA HS Program rules that include the following:

- Teams will play 11 v 11 with a maximum of 6 male field players at any one time. The goalie does not count as a field player and can be male or female. This means that teams must play with a minimum of 4 female players for each game or play with less than 11 players.
- **NOTE** – If registering as a Team, you need to also complete the team registration form – available on line. Must have at least 14 to register a team. Smaller groups not guaranteed to play together. All teams must have a coach to be accepted.
- Head coach must be at least 21 years of age.
- League will consist of two divisions – Minors (9th and 10th grade) and Seniors (11th and 12th grade). Based on fall 2010 grade.
- All teams will have a Club roster and players must have a picture ID (i.e. drivers license or school ID) Referees will check players against rosters at the start of each game. **At each game, players must have ID to be allowed to play and coaches must have rosters for game to be considered sanctioned.**
- 8 Scheduled League games.
- Adult Referees

REGISTRATION AND INFORMATION

The Centerville Recreational Soccer League d/b/a CUSA, is a not-for-profit organization that offers a variety of programs for players' ages 5 – 19 to learn the sport of soccer and play at the level that best suits their interest and ability.

Our high school coed recreational soccer program is designed to provide an opportunity for young adults in grades 9 – 12 to play and enjoy the game of soccer in a safe, healthy, and social environment. **This program is not open to any child who is participating in an organized competitive (select), club soccer program or playing for a high school soccer team.**

Program is subject to change based on final enrollment numbers and field availability. Changes will be consistent with the bylaws of the organization and with the intent of providing the best possible program for your child.

CUSA is affiliated with the United States and Ohio South, Youth Soccer Associations.

TEAM FORMATION

Teams will be made up of male and female players consisting of two Divisions. Each team should have a minimum of 6 female players. **Teams will not exceed 18 players without prior approval.** The Minors Division consists of 9th and 10th graders, with Senior Division consisting of 11th and 12th graders. **Teams must be at least 85% within Divisional Grade. Teams must be at least 51% Centerville – Washington Twp. residents.**

Participants are encouraged to organize their friends and register as an entire team (no more than 18 players). Participants may also register individually or with a small group of friends and will be assigned to a team needing additional players. **If registering as a team, please use the team**

registration form available on line. Please bring registration forms and team form to the onsite registration.

Each team must be represented by an adult head coach age 21 or older. It is strongly encouraged that the head coach be a parent of a player on the team. **If you are not a resident of Centerville/Wash. Twp. there is a non resident fee this year.**

COST

Registration fee includes t-shirt and socks, referee costs, tournament and league membership.
